3	SECTION 1. SHORT TITLE.		
4	This Act may be cited as the "New River Gorge Na-		
5	tional Park and Preserve Designation Act".		
6	SEC. 2. DESIGNATION OF NEW RIVER GORGE NATIONAL		
7	PARK AND NEW RIVER GORGE NATIONAL		
8	PRESERVE, WEST VIRGINIA.		
9	(a) Redesignation.—The New River Gorge Na-		
10	tional River established under section 1101 of the Na-		
11	tional Parks and Recreation Act of 1978 (16 U.S.C.		

- 1 460m-15) shall be known and designated as the "New
- 2 River Gorge National Park and Preserve", consisting of—
- 3 (1) the New River Gorge National Park; and
- 4 (2) the New River Gorge National Preserve.
- 5 (b) New River Gorge National Park.—The
- 6 boundaries of the New River Gorge National Park referred
- 7 to in subsection (a)(1) shall be the boundaries depicted
- 8 as "Proposed National Park Area" on the map entitled
- 9 "New River Gorge National Park and Preserve Proposed
- 10 Boundary", numbered 637/163,199A, and dated Sep-
- 11 tember 2020.
- 12 (c) New River Gorge National Preserve;
- 13 Boundary.—The boundaries of the New River Gorge Na-
- 14 tional Preserve referred to in subsection (a)(2) shall be
- 15 the boundaries depicted as "Proposed National Preserve
- 16 Area" on the map entitled "New River Gorge National
- 17 Park and Preserve Proposed Boundary", numbered 637/
- 18 163,199A, and dated September 2020.
- 19 SEC. 3. ADMINISTRATION.
- 20 (a) In General.—The New River Gorge National
- 21 Park and Preserve shall be administered by the Secretary
- 22 of the Interior (referred to in this Act as the "Secretary")
- 23 in accordance with—
- 24 (1) this Act;

1	(2) the laws generally applicable to units of the
2	National Park System, including—
3	(A) section 100101(a), chapter 1003, and
4	sections 100751(a), 100752, 100753, and
5	102101 of title 54, United States Code; and
6	(B) chapter 3201 of title 54, United States
7	Code; and
8	(3) title XI of the National Parks and Recre-
9	ation Act of 1978 (16 U.S.C. 460m-15 et seq.), ex-
10	cept that the provisions of section 1106 of that Act
11	(16 U.S.C. 460m-20) relating to hunting shall not
12	apply to the New River Gorge National Park.
13	(b) Hunting and Fishing.—
14	(1) Hunting.—Hunting within the New River
15	Gorge National Preserve shall be administered by
16	the Secretary—
17	(A) in the same manner as hunting was
18	administered on the day before the date of en-
19	actment of this Act in those portions of the
20	New River Gorge National River designated as
21	the New River Gorge National Preserve by sec-
22	tion 2(e); and
23	(B) in accordance with—

1	(i) section 1106 of the National Parks
2	and Recreation Act of 1978 (16 U.S.C.
3	460m–20); and
4	(ii) other applicable laws.
5	(2) Fishing.—Fishing within the New River
6	Gorge National Park and Preserve shall be adminis-
7	tered by the Secretary—
8	(A) in the same manner as fishing was ad-
9	ministered within the New River Gorge Na-
10	tional River on the day before the date of enact-
11	ment of this Act; and
12	(B) in accordance with—
13	(i) section 1106 of the National Parks
14	and Recreation Act of 1978 (16 U.S.C.
15	460m–20); and
16	(ii) other applicable laws.
17	(3) Private Land.—Nothing in this Act pro-
18	hibits hunting, fishing, or trapping on private land
19	in accordance with applicable State and Federal
20	laws.
21	(c) Land Acquisition.—
22	(1) Additional land for national pre-
23	SERVE.—
24	(A) IN GENERAL.—The Secretary may ac-
25	quire land or any interest in land identified as

1	"Proposed Additional Lands" on the map enti-
2	tled "New River Gorge National Park and Pre-
3	serve Proposed Boundary'', numbered 637/
4	163,199A, and dated September 2020, by pur-
5	chase from a willing seller, donation, or ex-
6	change.
7	(B) Boundary modification.—On ac-
8	quisition of any land or interest in land under
9	subparagraph (A), the Secretary shall—
10	(i) modify the boundary of the New
11	River Gorge National Preserve to reflect
12	the acquisition; and
13	(ii) administer the land or interest in
14	land in accordance with the laws applicable
15	to the New River Gorge National Preserve.
16	(2) Visitor parking.—
17	(A) IN GENERAL.—The Secretary may ac-
18	quire not more than 100 acres of land in the
19	vicinity of the New River Gorge National Park
20	and Preserve by purchase from a willing seller,
21	donation, or exchange to provide for—
22	(i) visitor parking; and
23	(ii) improved public access to the New
24	River Gorge National Park and Preserve.

1	(B) Administration.—On acquisition of
2	the land under subparagraph (A), the acquired
3	land shall be administered as part of the New
4	River Gorge National Park or the New River
5	Gorge National Preserve, as appropriate.
6	(d) Commercial Recreational Watercraft
7	Services.—Commercial recreational watercraft services
8	within the New River Gorge National Park and Preserve
9	shall be administered by the Secretary in accordance with
10	section 402 of the West Virginia National Interest River
11	Conservation Act of 1987 (16 U.S.C. 460m-15 note; Pub-
12	lic Law 100–534).
13	(e) References.—Any reference in a law, map, reg-
14	ulation, document, paper, or other record of the United
15	States to the New River Gorge National River shall be
16	considered to be a reference to the "New River Gorge Na-
17	tional Park" or the "New River Gorge National Preserve",
18	as appropriate.
19	SEC. 4. AUTHORIZATION OF APPROPRIATIONS.
20	There are authorized to be appropriated such sums
21	as are necessary to carry out this Act.
